WHEREAS, the PCA through the CO BAC issued Request for Expression of Interest (REI) for Public Bidding No. 01-2021 more particularly described as Consultancy Services for the Engagement of External Certifying Body for the PCA ISO 9001:2015 Certification with an ABC amounting to Php500,000.00;

WHEREAS, on March 12, 2021, the CO BAC conducted the Opening of Eligibility Documents for the subject procurement wherein two (2) bidders submitted eligibility documents namely WQA Phils., Inc. and SOCOTEC Certification Philippines, Inc.;

WHEREAS, during the said evaluation the submitted eligibility documents of WQA Phils., Inc. failed to hurdle the non-discretionary pass-fail evaluation due to non-compliance with the required number of copies of eligibility documents to be submitted under Sec. 4.2 and Eligibility Data Sheet of the bidding documents. Thus, declared ineligible for the subject procurement;

WHEREAS, the submitted eligibility documents of SOCOTEC Certification Philippines, Inc. passed the non-discretionary pass-fail evaluation and was declared eligible;

WHEREAS, based on the evaluation for shortlisting of consultants undertaken by the Technical Working Group (TWG) for the subject procurement, SOCOTEC Certification Philippines, Inc. was shortlisted;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the CO BAC, hereby RESOLVE as it is hereby RESOLVED to recommend to the HoPE the shortlist of consultant for Public Bidding No. 01-2021 more particularly described as Consultancy Services for the Engagement of External Certifying Body for the PCA ISO 9001:2015 Certification indicating thereto the lone shortlisted consultant to be SOCOTEC Certification Philippines, Inc.
