RESOLUTION No. 13, Series of 2020

FAILURE OF BIDDING
PUBLIC BIDDING No. 01-2020

WHEREAS, the PCA, as the Procuring Entity through its Central Office Bids and Awards Committee (CO BAC) posted Public Bidding No. 01-2020 for the Supply, Delivery, Installation and Commissioning of Various Laboratory Equipment for the Development of Coco Sap Wine which is composed of Five (5) Lots;

WHEREAS, four (4) prospective bidders bought bidding documents for the following lots:

ITS Science Philippines - Lot Nos. 1, 2, 3, 4 and 5
Krypton Industrial Resources Co - Lot Nos. 3 and 5
Noveaulab Asia Corp - Lot Nos. 3, 4 and 5
Camprock Analytika Ezzentialez Trading - Lot Nos. 1, 2 and 3

WHEREAS, on November 4, 2020, the CO BAC conducted the opening of bids for the subject procurement;

WHEREAS, during the said opening of bids only the three (3) prospective bidders namely: 1) Camprock Analytika Ezzentialez Trading; 2) Krypton Industrial Resources Co.; and 3) Noveaulab Asia Corp submitted their corresponding proposals on the above-mentioned lots;

WHEREAS, all the three (3) prospective bidders, Camprock Analytika Ezzentialez Trading, Krypton Industrial Resources Co. and Noveaulab Asia Corp. failed to hurdle the non-discretionary pass-fail evaluation process due to insufficiency of the submitted Certificate of undertaking that spare parts shall be available 5-10 years from the date of acceptance; Thus, the three (3) bidders were declared ineligible;

WHEREAS, the CO BAC received a Motion for Reconsideration (MR) from the three (3) bidders within the prescribed period;

WHEREAS, on November 16, 2020, the CO BAC denied the cited MR under CO BAC Resolution Nos. 10, 11 and 12 by virtue of Sec. 30.0 and Sec. 55.1 of RA 9184's IRR;

NOW, THEREFORE, for and in consideration of the foregoing, We, the members of the PCA CO BAC, hereby RESOLVE as it is hereby RESOLVED, to declare a Failure of Bidding for Public Bidding No. 01-2020 for the Supply, Delivery, Installation and Commissioning of Various Laboratory Equipment for the Development of Coco Sap Wine in accordance with Sec. 35 of RA 9184's IRR and conduct a Re-bid for the subject procurement commencing with Re-posting.
