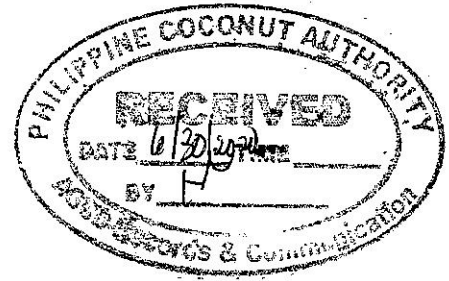

Pursuant to Board Resolution Nos. 052-2020 and 063-2020, the following Regional Offices shall be renamed as follows:

FROM	TO
REGIONS I-IVB	REGION I, II, III and CAR
REGION IVA	REGION IV

To rationalize the distribution of provincial offices in the affected regions, the following re-clustering and transfer of administrative supervision is hereby effected:

Incumbent Regions I-IVB Regional Manager III shall continue to head the renamed Regional Office (Region I, II, III & CAR). Existing personnel assigned to the Office of the Regional Manager (including the Administrative Unit) of PCA Regions I-IVB shall be continue to be assigned under the renamed Regional Office notwithstanding any change in the physical location of said Regional Office.

Similarly, all existing personnel assigned under the above-listed provincial offices shall continue to be assigned under the same provincial offices notwithstanding the adjustment in their clustering and supervision.

Regional Managers of the affected regions are hereby directed to carry out the above changes expeditiously and shall effect an orderly turn-over of resources, records, responsibilities and accountabilities as necessary. Turn-over/implementation reports shall be submitted, not later than 15
