STAFFING OF PCA OFFICERS

In view of the lifting of the election ban on re-assignments and movements, the following changes in the staffing of PCA officers is hereby implemented effective July 1, 2019:


### A. Re-call of Officers to Original Plantilla Positions

This will revoke Special Orders #103 (dated July 27, 2019), #103-B (dated August 17, 2018), and #139 (dated September 6, 2018). The massive reorganization of PCA took a heavy toll on operations.
