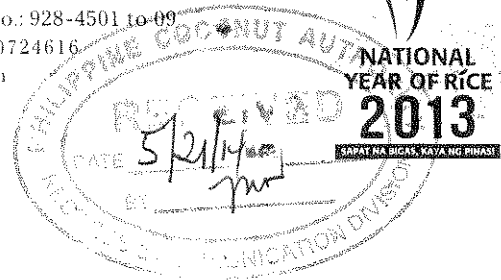

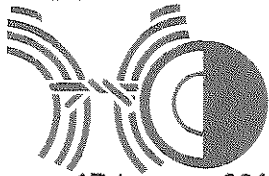

SUBJECT : **ADJUSTMENT IN THE GRANTING OF MOBILE TELEPHONE ALLOWANCES**


